 -The Community Recovery Grant application was sent Sept 15th. The \$20,000 arrived Oct 5th. Anything we haven't spent by Dec 5th goes back to LCIF for other disasters. Proposals to consolidate our shopping and to add wheelbarrows were discussed.
 -No auditor report for 2019-2020 year as of yet. Tax return relief has delayed the tax season.

Dues Relief

DG David Beeman
 -In place due to COVID 19's impact on finances.
 -International board adopted a resolution that they would not suspend a club for not paying dues until DEC 31, 2020.
 -There are a record number of clubs who have not paid balances.
 -They will let us know who has not paid. Can check online at any time.
 -There will be a suspension warning in the online statement.
 -As of Jan 1st, clubs will be placed on financial suspension if they are \$100-1000 in arrears.
 -By MAR 1st, those clubs will be automatically cancelled if not paid.
 -In December, the next round of dues payments are due as well. So the amount due to stay in good standing, they club will have to pay the back payment and the new bill that is due in December
 -Let your Zone/Region Chair know if you have an issue in your club. As a district we can decide how we are going to deal with these clubs to assist them.

Lion Bill Munoz

-Presented training on the youth protection policy (see attached)

-The clarification that clubs which sponsor campus-based LEO clubs must send the name of the faculty advisor and the name of that LEO Club to our District Youth Protection Officer Lion Bill Muñoz of Kings Lions, 559-707-9062 was important. Lion Bill also recommends that clubs which sponsor campus-based LEO clubs also name a Lion as a liaison to the LEOs.

-Clubs with community-based LEO clubs must follow all the Youth Protection steps found in the MD-4 policy on the MD-4 website. This includes adopting the Youth Protection policy and appointing a club Youth Protection Officer. They may not need to use the exact MD-4 procedures if the ones the club uses are more stringent and include review by the district.

-Lions Clubs sponsoring either kind of LEO Club must certify as "Lions Youth Volunteers" anybody who they expect to regularly drive LEOs to events. The steps are on the MD-4 website. There is a great FAQ section on the website, too.

DISTRICT 4-A2 CABINET MEETING
Lions Clubs International Foundation Report – November 7, 2020

Governor David has asked me to talk a little about some of the Recognitions available for donations to the Lions Foundation. (Show slides).

Shortly after the Creek Fire started, District Governor David applied for a Community Recovery Grant from LCIF. This grant was for \$20,000. Some Lions or Clubs have been busy, shopping at Lowe's (for one example) to buy items to help people in Shaver Lake who lost their homes. Others delivering the hardware items, as well as other needed supplies. The Shaver Lake Lions have been doing a very big part in handing out the tools to the residents of Shaver Lake. Our Treasurer, Lion Jan, will give the specific details in her report later.

Because most of our clubs have not been able to do their usual fundraising projects, donations have been down to LCIF. Through the end of October, our clubs have only sent in \$2,756.86. We do now have a very good example of the impact the donations to LCIF can make, as we have seen in Shaver Lake. Some people have gotten very creative in different ways to do fundraising and have made some very nice donations to LCIF. There will be another Giving Tuesday on December 1, 2020. Those who do Facebook and other Social Media will understand this much better than I do. I have information I can get if you would like to participate in this way.

Back in February we had an LCIF Dinner fundraiser, held in Visalia, with Past International President Joe Preston coming to be the keynote speaker. I would like to try another fundraiser, but because of the Coronavirus, would like to try something different for 2021. Like have an "LCIF Non-Dinner Fundraiser" via Zoom, with a speaker or two. And to do it on Zoom which should make it easier to get some Lions from outside of the District. Possibly share some LCIF videos. Lion Emily, our District Tail Twister, has said she would come up with some games we could do. I would really like a few other people to help be on a committee, so please let me know if you might be interested. There would be, say a Registration fee, or a Requested donation to "attend". Our District Governor has suggested Friday, January 15th, which is two days after Melvin Jones' birthday.



The City of Hope Story



The City of Hope story began in 1913, when a group of volunteers, spurred by compassion to help those afflicted with tuberculosis, established the Jewish Consumptive Relief Association (JCRA) and raised money to start a free, nonsectarian tuberculosis sanatorium on 10 acres of sun-soaked land in Duarte, where they would establish the Los Angeles Sanatorium.

To earn this designation, a center must undergo a rigorous peer-review process, maintain a high number of cancer research projects and be heavily involved in community outreach, as well as meet other academic and public service requirements. City of Hope earned its comprehensive cancer center designation in 1998 and has maintained it since.

#4 in Patient Experience

This year, U.S. News & World Report added data from Hospital Consumer Assessment of Healthcare Providers and Systems, which tracks exemplary patient experience. City of Hope was ranked fourth in the country out of 885 hospitals surveyed.

City of Hope and Cancer

City of Hope continues to be at the forefront of a powerful form of immunotherapy known as **CAR T cell therapy**.

- Immune cells are taken from a patient's own bloodstream, reprogrammed to recognize and attack a specific protein found in cancer cells, then reintroduced into the patient's system, where they destroy the targeted tumor cells.

City of Hope is a pioneering leader in the field of blood cancer.

- Since 1976 City of Hope's bone marrow and stem cell transplant program has grown into one of the largest, most successful programs of its kind in the United States, with more than 15,000 procedures performed to date.

City of Hope and Diabetes



Although world renowned for its work in research and treatment of cancer, City of Hope has a long and impressive history of groundbreaking discoveries in the field of diabetes. It spans seven decades of intense investigation since the discovery of the effect of insulin in the 1940s. Researchers at City of Hope were the first to identify the marker for blood glucose control, which remains the gold standard used by physicians around the world to manage patients with diabetes.

Synthetic human insulin, which is used worldwide by millions of people with diabetes, was first discovered and produced at City of Hope.

At virtually every turn on the City of Hope campus there is a ready evidence of Lions' generous support to City of Hope.

The Lions Clubs International Japanese Garden, located in the center of the City of Hope campus, has been a shining beacon of the Lions' commitment to helping people in need. In 2018, with an official ribbon cutting ceremony, the Lions Clubs International Family Center at City of Hope was officially unveiled. The completion of the Lions Clubs Family Center fundraising program, provided a vast restoration of this crucial part of City of Hope's campus that enables patients to remain close to medical treatment and supportive care services while continuing their outpatient care.

Why Diabetes is an Epidemic

- An estimated **30 million** Americans have diabetes, and nearly **1 in 4** of those are unaware of the condition.
- Diabetes is a leading cause of **adult blindness** in Americans. Diabetics are 40% more likely to have glaucoma and 60% more likely to have cataracts. Left unchecked, vision loss due to diabetes is **irreversible**.
- Diabetes is the **seventh leading cause of death** in the U.S., and it contributes to mortality from heart disease, stroke and kidney failure. Type 2 diabetes is also associated with an **increased risk for several cancers**, including pancreas, liver, breast, colorectal and genitourinary.
- Since 1980, worldwide rates of type 2 diabetes have **quadrupled**.
- The number of obese children and adolescents has soared **tenfold**, setting the stage for an epidemic of type 2 diabetes.

The Lions Clubs Diabetes Innovation Fund at City of Hope

- City of Hope and The Lions Clubs International to partner on finding new ways to prevent and treat type 2 diabetes and its complications.
- The Lions Clubs Diabetes Innovation Fund will consist of projects that are diverse in aims, with studies identified and prioritized by their potential to advance research on type 2 diabetes and its many complications.
- The Fund would support the most promising new ideas through a competitive selection process that would award two or more seed grants up to \$100,000 per year, with the potential for renewal. The selection process and oversight would be conducted by a team of expert City of Hope researchers.
- With a total investment of \$1,000,000 over five years, Lions Clubs will have the opportunity to establish the Lions Clubs Diabetes Innovation Fund and drive research leading to prevent and treat type 2 diabetes.
- We have set a global goal to confront diabetes. Combining research advances with our community and patient support efforts will make an enduring impact on the future of the disease, and on humanity.

Why a Youth Protection Policy?

- Being Proactive
- Reduce risk to youth, Lions members and the organization
- To create and maintain a safe environment for youth who participate in Lion activities
- Lions, Lion's spouses, partners and other volunteers MUST safeguard the children and young people they come into contact with and protect them from physical, sexual, mental and emotional abuse.



School Based vs Non-School Base

- **Alpha Leos Clubs – School Based**

- School based Leos Clubs meet on school site. They are required to have a faculty Leo Advisor. The faculty Leo Advisor follows the California school district clearance policy and procedures. Therefore, they are exempt from the MD4 policy and procedures. They only need to provide a letter from the school district identifying the faculty advisor and the name of the Leos Club to the District and MD4 Area Youth Protection Officer.

- Club Leo Advisors, Lion Youth Programs Advisors, volunteers which include but not limited to Youth Exchange, Kids In Sight, Youth Outreach, etc. are not exempt from the policy and procedures process.

- If the youth program has a Youth Protection policy and procedure in place, they must provide a copy of their Youth Protection Policy and verify that it is no less than the MD4 policy and procedures. They may choose to have more stringent requirements than the MD4 policy but not less than.

- ALL clubs that participate or wish to participate in Youth Service Programs MUST comply with the Policy and Procedures. Non-compliance may result in a referral to Lions Clubs International and a restriction in working with youth.

Infrequent vs Frequent Contact

•Infrequent Contact

- These are volunteers who are indirectly involved and are not directly responsible for Multiple District 4 Lions Youth Service Program participants.

- Volunteers who have infrequent casual contact with youth are not required to be screened. However they must be accompanied by three or more people and one of them **MUST** include a Lions Youth Leader.

- Contact with youth must be in a group setting with no reasonably foreseeable risk of abuse or harassment.

•Frequent Contact

- These are adults who have ongoing and constant role in a Lions Youth Program. All adult volunteers must complete the screening and training procedures for volunteers.

- Includes but not limited to Leo Advisors, Youth Exchange Host Families, those who work closely with Leo participants and/or who provide transportation for youth to and from meetings or events on a regular basis.

- All cleared volunteers will be identified as a Lions Youth Leader.



Role of the District Governor

Designate a District Youth Protection Officer (*Custodian of Records*).

District Governor and District Youth Protection Officer determine in-house communication and maintenance of volunteer information protocols.



Suggested Protocols for Handling of Information



- Determine who will receive and manage Volunteer Applicant Information: Club Youth Protection Officer **or** District Youth Protection Officer
- **Option 1: (Recommended)** Purchase an encrypted USB Flash drive (Password Protected). After inserting flash drive to computer/laptop, create folders for each volunteer. Scan documents and save to the volunteers designated file. After scanning and verifying all information is saved to the flash drive, documents can be shredded/destroyed. Make sure the Volunteer Application and Reference Checks are included. They need to be kept for at least two years.

Suggested Protocols for Handling of Information *(Continued)*

- **Option 2:**

Prepare a log/list in either Word or Excel. Label columns with volunteer names, listing of required documents, date of receipt, document expiration dates, verified by, etc. After logging in all information, you can shred/destroy documents. Make sure you save your information as you update before shredding/destroying documents. Only need to keep Volunteer Applications and References for at least two years.

- **Option 3:**

Hard copies: Obtain a file cabinet with a secure lock. Recommend at least two authorized members have access to the secure cabinet. Create a folder for each volunteer. Store all information pertaining to the volunteer in their designated file.



Role of the District Youth Protection Officer

- Initiate contact with district clubs.
- Obtain contact information for the Club Youth Protection Officer and/or Leo Advisor.
- Verify Club Compliance Form (*Appendix F*) is on file with the District and the MD4 Area Youth Protection Officer.
- Collect/Verify receipt of volunteer documents.

Who Keeps Volunteer Records?

- District and Club Youth Protection Officers are encouraged to scan all documents and maintain all volunteer information on an encrypted flash drive. It is not recommended to keep a hard copy of confidential information.
- District and/or Club Youth Protection Officers maintain all information such as Volunteer Applications, TB Test, Driver's License, Driving Record, Auto Insurance, BSA Online Youth Protection Training Certificate (75 Minute) and Reference Checks.
- District Youth Protection Officers forward dates of volunteer's TB Test Clearance, Driver's License, Driving Record & Insurance, BSA Online Youth Protection Training Certificate to the Area Youth Protection Officer
- MD4 Area Youth Protection Officers maintain roster of all cleared Youth Volunteers in their Area along with TB Test Clearances, Driver's License, Driving Record & Insurance & BSA training certificate dates.
- Sterling Volunteers (*MD4 Authorized Provider*) maintain all confidential background clearance information.

Role of the MD4 Area Youth Protection Officer

- Receipt of completed and signed MD4 Club Compliance Form from all who sponsor a youth and/or LEOS program.
- Receives notifications from Sterling Volunteers.
- Reviews notification of volunteer applicant clearances.
- Contact District Youth Protection Officer or District Governor of clearance results.
- Request volunteer applicant verifications from District Youth Protection Officer or District Governor:
 - ✓ Volunteer Application
 - ✓ TB Clearance Date
 - ✓ Driver's License, Auto Insurance Expiration Dates and Driving Record Copy of BSA Online Youth Protection Training Certificate



Volunteer Certification

- Confirmation receipt of all required documents.
- Issuance of MD4 Youth Protection Leader Certificate of Compliance to the volunteer applicant.
- Compliance Certificate will be sent to District Youth Protection Officer and provided to volunteer.
- Certificate is only valid if non-expired documents are on file.

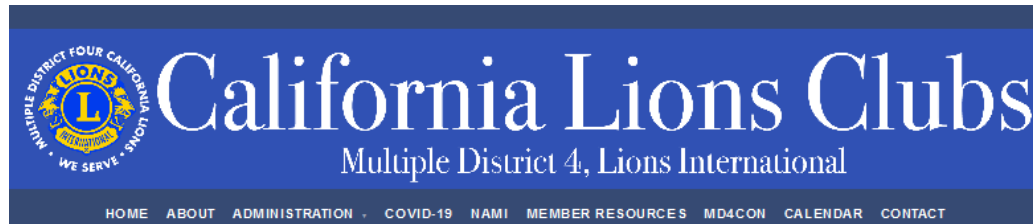
Volunteer Applicant Steps

- Volunteer Application (*Appendix C*) – Kept by Club and/or District Youth Protection Officer.
- Background/Criminal Record Check – Sterling Volunteers
- Three Personal Reference Checks (*Appendix D*) Employment/Volunteer Reference Checks (if applicable) (*Appendix E*) – *Recommended but not required.*
- Proof of TB Clearance (within last two years)
- BSA Online Youth Protection Training – Certificate of Completion – Valid for two years.
- If transporting youth, proof of valid Driver's License, driving record and auto insurance.

Report Allegation of Abuse or Harassment

- **All adults to whom a youth or someone on behalf of a youth reports an incident of abuse, harassment, or neglect MUST record and report the allegation following the established guidelines in Appendix B**
- The adult to whom the allegations were reported MUST immediately contact their Youth Protection Officer, who in turn **MUST immediately contact local law enforcement** and their Area Youth Protection Officer.
- Inform the District Governor of any allegation of sexual abuse or harassment made by or on behalf of a youth program participant.
- Maintaining a record of all allegations made.
- Ensure proper handling of allegations, according to local laws and MD4 Youth Protection Policy and Procedures, and protection of the interests of all involved.
- Ensure that Volunteer Applications, background clearances, and references for adult volunteers working with youth are maintained for at least two years and are kept confidential.

Youth Protection Policy and Procedures Frequently Ask Questions & Answers

1. What is the first step that a Lion should do when considering working with youth through Lions?

A: Go to MD4 California Lions Website at:

<https://md4lions.org/youth-protection-policy>

Become familiar with manual and all procedures listed. If you have any questions, contact your Area Youth Protection Officer.

2. Do Lions in our club who do transport for the Lions All-Star- Football for the dinner that the Lions Club usually does for the team have to be cleared through the Lions Youth Protection Program?

A: Yes, if it is not school based – Refer to Youth Protection Policy & Procedures – Page 3 under Types of Volunteer Contact with Youth – Infrequent or Occasional Contact

1. Sometimes we have retired teachers who go into the schools to do Flag Day with the kids. They are not alone with kids, but would they have to go through the Lions Child Protection Program to do in school presentations?

A: No, they do not have to go through the Lions Youth Protection clearances. The volunteer is in a classroom setting in the presence of the teacher of record.

2. Does a retired police officer, teacher, clergy, fire fighter, etc. need to go through clearances?

A. Yes/No: Being a retired official is not relevant, it is based on frequent or occasional contact. Refer to Youth Protection Policy & Procedures – Page 3 under Types of Volunteer Contact with Youth – Infrequent or Occasional Contact

3. When we are done with submitting all the documentation and pass everything, do we get a certificate to present saying that we have clearance to work with youth?

A: Yes, a Certificate of Compliance will be issued by the Area Youth Protection Officer.

4. How does the Youth Protection Policy work with Lions Camp if we have club members who go to Camp to cook? Do they need to go through the Youth Protection Training and pass to be able to cook at Camp?

A: Yes, if they are alone with the youth and/or supervising them.

A: No, if they are only cooking and have no supervisory responsibilities and not alone with youth.

5. Who is responsible for making sure all camp staff/faculty are cleared?

A: The District Endorsed Camp entity is responsible for providing youth protection clearances to the District Youth Protection Officer. *(For example: California Lions Camp – Camp Pacifica and Lions Camps at Teresita Pines.)*

6. Sometimes Youth are in the public-school system up to the age of 21 if they have special needs. If they are going to Camp as a part of the Leos Club for training, do they need to be cleared through the Lions Child Protection Program? Our Leos Club is through an alternate education program so this could be an issue.

A: PDG Manny is waiting to receive information from the state.

7. Does a Youth Exchange student who are 18 years or older staying with a Host Family need to be cleared under the Youth Protection Policy?

A: No. The Youth Exchange student is a guest from a foreign country.

8. Does everyone 18 years and older living in a Host Family home need to be cleared under the Youth Protection Policy?

A: Yes. Every one living in a Host Family home that is 18 years or older needs to be cleared under the Youth Protection Policy. In the United States all individuals 18 years and older (even if they are in High School) are considered adults.

9. Which Boy Scout Training are we supposed to take basic (45 min) or advanced (72min)?

A: Advanced (72 Minute)

10. Our Leo Advisors for our Lions Club are the Vice Principal at the high school and another teacher who is on the staff of the school where the Leo Club is located. Both are fingerprinted through the school district and would be covered to transport kids and supervise kids off campus because they work for the school district. Do they need to go through Lions Youth Protection Training?

A: No, it is a school based extra-curricular activity – Refer to Youth Protection Policy, Page 2 under Statement of Conduct for Working with Youth.

11. Can an adult take a youth just a short distance in a car without becoming a Lions Youth Leader?

A: No -- There must be a designated Lion Youth Leader, who must also have a Driver's License and Insurance on file. Refer to Youth Protection Policy & Procedures – Page 3 under Types of Volunteer Contact with Youth – Infrequent or Occasional Contact

12. Do Lions working in a school-based Leo program need to be designated as Lion Youth Leaders?

A: No, Refer to Youth Protection Policy, Page 2 under Statement of Conduct for Working with Youth.

13. Who keeps records for the volunteers?

A: Sterling Volunteers maintains all confidential background clearance information.

Area Youth Protection Officers maintain roster of all cleared Youth Volunteers in their Area along with TB Test Clearances, Driver's License & Insurance expiration dates & training certificate. District Youth Protection Officers need to forward expirations dates of volunteer's TB Test Clearance, Driver's License & Insurance.

District and Club Youth Protections Officers maintain all other information such as Volunteer Applications, TB Test, Driver's License, Insurance and Reference Checks.

District and Club Youth Protection Officers are encouraged to scan all documents and maintain all volunteer information on an encrypted flash drive. It is not recommended to keep a hard copy of confidential information.

14. What do you put under Affiliated Organization for Sterling Volunteers?

A: Enter your District – For example: District 4 L5

15. Who is responsible for conducting Personal & if applicable Employment Reference checks?

A: It is up to the District Governor to set up. Reference Checks can be done by the District Youth Protection Officer or the Club Youth Protection Officer. Refer to Youth Protection Policy, Page 4 under Management of Screening Process.

16. Is there a standardize form/template of questions to ask?

A: Refer to Youth Protection Policy, *Appendix D: Sample Personal Reference Questions for Telephone Interview* and *Appendix E: Sample Employment/Volunteer Reference Questions for Telephone Interview*. Yes, you can modify the forms.

17. What do we do with the completed reference checks once they are completed?

A: Upon completion of the volunteer screening process and is certified as a Lions Youth Leader, all reference notes can be destroyed.

18. What happens if there is a negative reference provided by one of the interviewees?

A: Club Youth Protection Officer informs the District Youth Protection Officer and District Governor. If needed, District Governor can refer matter to Area Youth

Protection Officer. If necessary, matter will then be addressed by the MD4 Youth Protection Committee Members.

19. What if someone refuses to provide information on the volunteer applicant?

A: Recommend the Volunteer Applicant inform those listed on the application to make them aware who and why they are being contacted.

20. Considering all the lawsuits of abuse, why is the Boys Scouts of America training selected?

The Boy Scouts of America was chosen because the training is free to anyone who wants to take the training. The training covers the important aspects of protecting youth. The Boy Scouts of America training was not what caused the lawsuits? The lawsuits were the result of the following through on monitoring and follow up on reported allegations of suspected abuse. This responsibility falls to everyone who is a volunteer with youth, Lion Youth Leaders, Clubs, and Districts sponsoring youth programs.

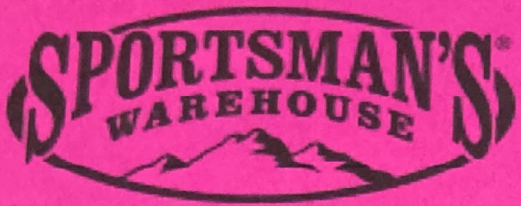
